## Rates for toddler care 2022 Son en Breugel.

(for clients who are not eligible for a childcare allowance)

With effect from 1 January 2022, Korein charges the rates<sup>1</sup> listed below. These rates already take a possible municipal subsidy into account. Do you want to be eligible for a municipal-subsidy? When you have agreed to the placement, you will receive a contract with all relevant information from us. This states, among other things, that you must send us the most recent income details of you and your allowance partner (if this is the case). If we do not receive income data, you would have to pay the rate without subsidy<sup>3</sup>.

For our toddler care services, you will receive an invoice 11 months per calendar year. You won't receive an invoice in August.

1. The monthly amount on your invoice can differ from the gross monthly rate stated on our pricelist by a maximum of € 0,10.
2. If you have received an early childhood education and care referral (VE) from Jeugdgezondheidszorg (the Child Healthcare Centre), the municipality will pay for the additional 9,5 hours of care per week from the age of 2 years.
3. The unsubsidised amount is € 247,95 per month (11 terms).
