Calculate your costs

It may be that you are eligible for childcare allowance; a government reimbursement of your costs. You can check whether you are entitled to any allowance on the [Tax Office's website](#).

Are you not entitled to childcare allowance?

Are you not entitled to childcare allowance from the Tax Office? The municipality may contribute to the cost of toddler care. You will pay a parental contribution, where the amount depends on the joint gross income.
