Calculate your costs

It may be that you are eligible for childcare allowance; a government reimbursement of your costs. You can check whether you are entitled to any allowance on the <u>Tax Office's website</u>.

If you are entitled to childcare allowance, you will receive an income-dependent contribution from the Tax Office. Would you like to know exactly how much you will pay? Use our <u>calculation tool</u> for an easy personal calculation.





Are you not entitled to childcare allowance?

Are you not entitled to childcare allowance from the Tax Office? The municipality may contribute to the cost of toddler care. You will pay a parental contribution, where the amount depends on the joint gross income.

Do you have an Early Years Statement (VE-indicatie)?

Has your child been given an Early Years Statement (VE-indicatie) by the health visitor? Then you get 2 half-days of 4 hours extra, which are fully reimbursed by the municipality.

If your toddler has a VE indication, there are 2 options:

- You are entitled to childcare allowance. You get 8 hours for free from the municipality. You can apply for childcare allowance for the other 8 hours.
- You are not entitled to childcare allowance. You get 8 hours for free from the municipality. You pay an income-related contribution for the other 8 hours, see previous table.

Explanation of rates

- The toddler care in the municipality Son en Breugel is accessible from 2 years and 6 months. The Early Years Statement (VE-indicatie) is accessible from 2 years.
- The government rate for toddler care is € 10,71 per hour. This is the amount used to calculate the childcare allowance from the Tax Office.
- Toddler care is billed 11 times a year. July will not be billed.
- In 2025, no toddler care will be available in this municipality during school holidays.
