### Are you not entitled to childcare allowance?

Are you not entitled to childcare allowance from the Tax Office? The municipality may contribute to the cost of toddler care. You will pay a parental contribution, where the amount depends on the joint gross income.

### Explanation of rates

- The toddler care in the municipality Weert is accessible from 2 years.
- The government rate for toddler care is € 9,12 per hour. This is the amount used to calculate the childcare allowance from the Tax Office.
- Toddler care is billed 12 times a year.
